INVESTMENT OBJECTIVE AND STRATEGIES

The investment objective of the Picton Mahoney Fortified Multi-Asset Fund is to achieve long-term capital appreciation by investing primarily in global equity securities and global income securities while mitigating capital loss by engaging in hedging strategies for downside risk protection. Picton Mahoney Asset Management is the manager (the "Manager"), portfolio advisor (the "Portfolio Advisor") and the trustee (the "Trustee") of the Fund.

To achieve its investment objective, the Fund's portfolio will include a tactical blend of global equities, global fixed income securities, derivatives of the securities in these asset classes and cash. The Fund's tactical allocation to these asset classes is based on the Portfolio Advisor's general market outlook, which is derived from the Portfolio Advisor's proprietary fundamental and quantitative research and analysis.

The Fund will typically have exposure of 25% to 75% of its portfolio to global listed equity securities and 25% to 75% to global fixed income securities of public or private companies. However, based on the prevailing market conditions, the Portfolio Advisor may allocate up to 100% of its portfolio in any one asset class.

The global equity component will invest primarily in equities of issuers of varying sizes of market capitalization. The global fixed income component of the Fund's portfolio will be invested primarily in global high yield debt securities, and may also be invested in global investment grade debt securities, government bonds, loans, convertible bonds, preferred shares, and dividend-paying equity securities. The global equity and global fixed income components of the Fund's portfolio may be invested in equity and fixed income mutual funds managed by the Manager in order to obtain exposure to these securities.

The Fund may also choose to: i) invest up to 100% of its portfolio in foreign securities; ii) invest a portion of the Fund's assets in exchange-traded funds to gain exposure to the securities described herein; iii) engage in short selling in a manner which is consistent with the investment objectives of the Fund and as permitted by securities regulations; iv) engage in securities lending, repurchase and reverse repurchase transactions as permitted by securities regulations to seek to generate additional income; and v) use derivative instruments, such as options, futures, forward contracts and swaps, for both hedging and non-hedging strategies, in a manner which is consistent with the investment objectives of the Fund and as permitted by securities regulations, including to: 1) hedge against losses from changes in the prices of the Fund's investments and from exposure to foreign currencies; 2) implement option spreads by

purchasing an option on a security and simultaneously selling an option on the same security with the same expiry date; 3) write covered call options on the securities that the Fund owns in order to seek to generate income from option premium; and 4) gain exposure to individual securities and markets instead of buying the securities directly.

The Fund has also obtained exemptive relief from Canadian securities regulatory authorities to invest in ETFs listed on a Canadian or United States stock exchange that seek to replicate the daily performance of a widely-quoted market index (i) in an inverse multiple of 100%, or (ii) by a multiple of up to 200% or an inverse multiple of up to 200% (in either case, a "Permitted ETF"). In each case: (a) the investment would be made by the Fund in accordance with its investment objective; (b) the Fund would not short sell securities of any Permitted ETF; (c) the aggregate investment by the Fund in Permitted ETFs would not exceed 10% of the Fund's net asset value, taken at market value at the time of purchase; and (d) the Fund would not purchase securities of a Permitted ETF that tracks the inverse of its underlying index (a "Bear ETF") or short sell securities of any issuer if, immediately after such purchase or short sale, more than 20% of the net asset value of the Fund, taken at market value at the time of the transaction, would consist of, in aggregate, securities of Bear ETFs and all securities sold short by the Fund.

RISK

There is no assurance that the Fund will be able to achieve its total return, capital preservation and distribution investment objectives. There is no assurance that the portfolio will earn any return and no assurances can be given as to the amount of distributions in future years and that the net asset value (the "NAV") of the Fund will appreciate or be preserved.

While risks are numerous, we believe the following are the most pertinent ones to be mindful of today:

1. **Equity Investment Risk** – Equity investments, such as stocks, carry several risks. A number of factors may cause the price of a stock to fall. These include specific developments relating to the company, stock market conditions where the company's securities trade and general economic, financial and political conditions in the countries where the company operates. Since a Fund's unit price is based on the value of its investments, an overall decline in the value of the stocks it holds will reduce the value of the Fund and, therefore, the value of your investment. However if the price of the stocks in the portfolio increases, your investment will be worth more. Equity funds generally tend to be more volatile than fixed income funds, and the value of their units can vary widely.
2. **Fixed Income Investment Risk** – Certain general investment risks can affect fixed income investments in a manner similar to equity investments. For example, specific developments relating to a company and general financial, political and economic (other than interest rate) conditions in the country in which the company operates. For government fixed income investments, general economic, financial and political conditions may affect the value of government securities. Since a Fund's unit price is based on the value of its investments, an overall decline in the value of its fixed income investments will reduce the value of the Fund and therefore, the value of your investment. However, your investment will be worth more if the value of the fixed income investments in the portfolio increases.

3. Credit Risk – An issuer of a bond or other fixed income investment may not be able to pay interest or to repay the principal at maturity. The risk of this occurring is greater with some issuers than with others. For example, the risk of default is quite low for most government and high quality corporate securities. Where this risk is considered greater, the interest rate paid by the issuer is generally higher than for an issuer where this risk is considered to be lower. This risk could increase or decline during the term of the fixed income investment. Companies and governments that borrow money, as well as their debt securities, may be rated by specialized rating agencies. A downgrade in an issuer's credit rating or other adverse news regarding an issuer can reduce a security's market value. Lower rated debt instruments generally offer a better yield than higher-grade debt instruments, but have the potential for substantial loss.

RESULTS OF OPERATIONS

For the period January 1, 2019 to June 30, 2019, the net asset value of the Fund increased by approximately \$3.8 million from \$87.1 million to \$90.9 million. During the same period, performance on the Fund's portfolio increased its assets by \$6.1 million. The Fund also received \$17.2 million in proceeds, had net redemptions of \$19.4 million, and paid distributions totaling \$0.1 million. For the period January 1, 2019 to June 30, 2019, the Fund Class A units returned 6.47%, the Fund Class F units returned 7.04%, the Fund Class FT units returned 7.05%, the Fund Class T units returned 6.48%, and the Fund Class I units returned 7.63%. Class A, F, FT, T, and I units all underperformed the reference index (the "Performance Fee Index"). The Performance Fee Index is comprised of 15% S&P/TSX Composite Total Return Index, 30% MSCI World Index, 10% FTSE TMX Canada 30 Day T-Bill Index, 25% BofA Merrill Lynch Global High Yield Index, 5% BofA Merrill Lynch Global Corporate Index, and 15% BofA Merrill Lynch G7 Global Government Index reported in Canadian dollars. The Performance Fee Index returned 9.58% over the same period.

For the six months ended June 30, 2019, the Fund's asset mix continues to evolve toward later cycle positioning as driven by our proprietary asset allocation framework. Relative to the end-of-year review, our economic cycle model holds its highest probability of recession. As such, we have allocated a full weight to precious metals as a substitute for interest rate exposure / crisis hedge. As the Fund moves through its fourth year, we continue to believe it has delivered upon its objectives. Namely, to capture a reasonable amount of upside to the benchmark return, but substantially less downside volatility over a full cycle.

Our proprietary asset allocation framework remains a strong and transparent underpinning to our multi-asset / multi-strategy fund offerings, including the Picton Mahoney Fortified Multi-Asset Fund. We continue to engage in rigorous research to enhance Modern Portfolio Theory to build resilient portfolios and deliver optimal Sharpe Ratio throughout a cycle. We believe that as traditional portfolios come to terms with lower expected returns and higher volatility (given late cycle dynamics), investors who focused on "Quality of Returns" will see a differentiated offering herein.

We are pleased to report that there were no unusual trends in redemptions or sales which would affect the investments in the Fund. Likewise, the Fund's revenues and expenses demonstrated no significant deviation from

what was expected in the period. Given the differentiation of the strategy and the solid relative performance since inception, flows have been positive, and we foresee continued adoption. We believe there is ample opportunity for all funds in the Fortified suite to attain the benefits of scale (i.e. expense coverage) moving forward.

The Fund is structured to offer risk hedging strategies, within the construction and limitation of NI 81-102 guidelines. With our expectation that volatility typically marks late cycle behavior, the Fund continues to tactically manage a budget for downside protection, largely via hedging embedded in component equity and fixed-income strategies. There remains ample opportunity for enhanced hedging strategies at the "top" fund level. We continue to await the opportunity to prove the Fund's capability for more decisive allocations, as dictated by our framework and remain confident the strategy will be significantly differentiated in such an environment. The Fund does not apply leverage in the form of borrowing. Short positions are utilized to both capture return potential and mitigate risk in declining markets. Outside of the borrowed security, no further capital leverage is applied to these positions.

RECENT DEVELOPMENTS

After signaling a definitive "pause" in normalizing monetary conditions via continued rate hikes, the U.S. Federal Reserve ("the Fed") is now, to some extent, painted into a corner. Equity markets have rallied, as expected, after the pause and now seem to be treading water waiting for clearer signals as to whether the tightening program was too much or whether the Fed can engineer a soft landing against heightened recessionary risks. The trouble is that many signals are mixed at this point and could literally inflect one way or the other in the very near future.

Historically, during the second three-month period following a Fed pause, market returns start to bifurcate, depending on whether a recession is in sight or not. For the quarter ended June 30, markets have performed more in-line with a pre-recession scenario rather than the lead up to a more hopeful mid-cycle slowdown environment. To wit, equity returns were muted in Q2 while longer-term interest rates fell quite significantly. Credit spreads of poorer quality companies widened somewhat, indicating investors may have started demanding more compensation for liquidity and potentially increased solvency risks. In contrast, credit spreads have tended to behave well during previous lead ups to a mid-cycle slowdown. In addition, gold prices rose while crude oil prices fell which is again more typical of a pre-recession dynamic than a soft-landing one.

With the above in mind, we continue to focus on portfolio construction and risk management. Against a classic "balanced" construct, opportunities to diversify / redistribute equity risk are a hallmark of the Fund. While we continue to hedge equity and fixed-income component strategies within the Fund, we have also added other exposures as diversifiers and portfolio hedges. These allocations represent the disciplined process of adjusting asset mix based on our tactical economic cycle model. Currently, the model's probability of recession argues for more defensive positioning, but we remain attuned to the potential for a soft landing and extended cycle, based on near-term economic data in response to easing monetary conditions.

This is a critical juncture for markets. One gets the sense that the Fed must acquiesce quickly and in size to assuage market-based expectations for easing. We observe that the continued deterioration in macroeconomic fundamentals

globally might suggest a pause in hiking rates may even be too late. Trade tensions certainly do not help, and the global supply chain is feeling the brunt of what may be a broader ideological “war” between the U.S. and China. Against this backdrop, we remain steadfastly focused on portfolio construction, focused intently on Quality of Returns and believe the Fund’s unique approach to asset allocation and risk management highlights our portfolio construction discipline and expertise.

RELATED PARTY TRANSACTIONS

Picton Mahoney Asset Management is the manager (the “Manager”), portfolio advisor (the “Portfolio Advisor”), and trustee (“the Trustee”) of the Fund. The Manager is an investment manager focused on equity and fixed income securities investments with approximately \$7.3 billion of assets under management as of June 30, 2019. The Fund holds: i) 3,766,049 units (market value of \$47,158,463) totaling 80.52% of the net assets of Picton Mahoney Fortified Equity Fund; ii) 2,316,456 units (market value of \$27,048,336) totaling 6.96% of the net assets of Picton Mahoney Fortified Income Fund; iii) 481,311 units (market value of \$5,017,333) totaling 47.08% of the net assets of Picton Mahoney Fortified Active Extension Alternative Fund. For the period January 1, 2019 to June 30, 2019, the Manager has absorbed \$74,900 of expenses.

Management Fees

As a result of providing investment and management services, the Manager receives a management fee calculated and accrued daily based on the NAV of the class of units of the Fund, plus applicable taxes, payable on the last day of each calendar quarter. For the period January 1, 2019 to June 30, 2019, the Fund incurred management fees of \$593,735 plus applicable taxes. Management fees in respect of Class I units are direct fees negotiated with the investor, paid directly by the investor, and would not exceed the management fee payable on Class A units of the Fund. The Manager uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund’s shares, investment advice, as well as general administrative expenses relating to Picton Mahoney’s role as Manager. Out of the management fees that the Manager received from the Fund, the Manager paid trailer commissions of \$148,533 for the period January 1, 2019 to June 30, 2019.

Performance Fees

The Manager receives a performance fee in respect of each class of units of the Fund. The performance fee is equal to the daily NAV of the class of units of a Fund during the calendar quarter multiplied by 20% of the amount by which the total return of the class of units exceeds the total percentage increase or decrease in a reference index (the “Performance Fee Index”) since the end of the period for which the last performance fee was paid, plus applicable taxes. If at any time the total return of the class of units of a Fund is less than its Performance Fee Index, then no performance fee will be payable until the total return of the class of units of such Fund relative to its Performance Fee Index exceeds the amount of the deficiency calculated on a percentage basis. For the period January 1, 2019 to June 30, 2019, no performance fees were paid.

Independent Review Committee

The Fund receives standing instructions (the “SI”) from the independent review committee (the “IRC”). The SI constitutes a written approval or recommendation from the IRC that permits the Manager to proceed with specific action(s) set out in the SI on an ongoing basis. The SI is designed to ensure that the Manager’s actions are carried out in accordance with the law, the instrument and the Manager’s policies and procedures in order to achieve a fair and reasonable result for the Fund. The SI outlines actions related to i) Fees and Expenses; ii) Trade Allocations; iii) Broker Selections; iv) Code of Ethics and Conduct; v) Portfolio Pricing Issues, amongst other things. The Manager must provide the IRC with a written report summarizing each instance where the Manager has relied on the SI. For the period January 1, 2019 to June 30, 2019, the IRC did not provide any recommendations to the Manager.

In the period the shares are established, the MER is annualized. Effective August 20, 2019, the management fee was changed in respect of certain classes of the Fund. If the change to the management fee would have been in effect throughout 2019, the adjusted MER for each class of the Fund would be: Class A - 2.40%, Class F - 1.29%, Class FT - 1.29%, Class T - 2.40%. If the change to the management fee would have been in effect throughout 2018, the adjusted MER for each class of the Fund would be: Class A - 2.39%, Class F - 1.27%, Class FT - 1.27%, Class T - 2.39%.
- (5) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period. This figure includes an adjustment for the Fund's portion of the trading expenses for the underlying funds held.
- (6) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund. 




